Bhaktinagar, Dist-Jalpaiguri, Pin-734001 in the state of West Bengal, would like to lodge this Written Complaint against **Sri Barun Roy** (having contact No. 6294743163), S/o Ramesh Roy, resident of Near Radha Krishna Mandir, Khai Khai Bazar, North Ektiasal, P.O., Sevoke Road, P.S. Bhaktinagar, Dist-Jalpaiguri, Pin-734001. That since last few days the above mentioned person used to talk with my minor daughter namely **Miss Roshni Lama(D.O.B. 18/12/2006)** and he tried to tempt her by several ways that he will give her job in a private company and thereby he used to talk with my minor daughter. That after knowing the fact I complained about his such acts to his parents but his parents threatened me that they will sell my daughter and we won't be able to do anything as his family has a very good relation with all anti-social persons. That today i.e. on 28.10.2022, at about 12:00 PM I came to know form my neighbors that the above mentioned person took my daughter with him for Bhasan of Kali Puja and since then I along with my entire family are looking for them in every possible location but all gone in vain and I have strong believe that the above mentioned person in connivance with his family members have kidnapped my minor daughter for ill motive. Please take proper legal action against the accused person.
