Respected Sir,

With benign submission I, SI. Uttam Kumar Baghira presently Posted to Siliguri PS under your kind disposal do hereby lodge this written complaint against 25 to 30 unknown persons of Lal Mohan Moulik Ghat under Siliguri PS area to the effect that on 29.10.2022 at 11.05 hrs while I am performing CS-I mobile patrolling van duty at Airview More area Vide Siliguru PS MCC No. 1037/22 Date. 29.10.2022 along with CV/790. S Barman and CV/512. D Barman that time received an information that some of the locals who are constructing Chatt puja ghat on the Mahananda River Bed area. Accordingly myself along with force had been to the Lal Mohan Moulik Chatt Ghat area to verify the information in hand.

On arrival I found some of the locals making Chattghat maintaining all restrictions at the side of Mahananda River bank but also found at about 25 to 30 persons present in the river bed of Mahananda where there is a sand bag surrounded by river water adjacent to the Lal Mohan Moulik Ghat and they are making Chatt Puja Ghat in the river bed with sand bags and other articles by blocking the river water flow just near to the 5th Mahananda Bridge and also tried to make constructions by using bamboo and cloths by violating the respective order of National Green Tribunal. Therefore myself directed them to return to the river bank and also directed them not to make any construction in the river bed but they pay no heed to my wards, accordingly myself started addressing the locals with the Public address system attached to our patrolling van regarding the order passed by Honorable National Green Tribunal. The persons who were in the middle of the Mahananda River bed surrounded by water where it was very much difficult to reach them, after hearing the same also paid no attention to the announcement which conducted several times.

After announcement through the public address system myself along with force took preparation to go to the river bed and to stop the illegal construction made by the said unknown persons of the said locality, seeing our preparation they escaped from the sand bank situated middle of the river to the opposite bank of the Mahananda river along with the construction materials by vacant the river bed.

I therefore pray before you that a specific case may kindly be started against 25 to 30 unknown persons of Lal Mohan Moulik Ghat under Siliguri PS area for making illegal construction in river bed under proper sections of law and to arrange for its investigation.
