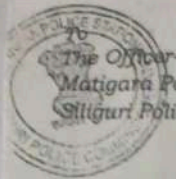

In producing herewith 02(Two) arrested accused persons namely i) Samir Roy (26 yrs) S/O Phani Roy of Khalaibhaktari, PS- Matigara Dist- Darjeeling and ii) Bijay Goswami (24yrs) S/O Goutam Goswami of Simultala Loknath Colony, PS- Matigara , Dist- Darjeeling along with seized articles :-

- 1) 17(Seventeen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Samir Roy.
- 2) 06 (Six) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Bijay Goswami
- 3) 05(Five) pieces of used Chocolate bomb (band sound Crackers) found at the Place of Occurrence.


I, SI Goutam Mallik of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above mentioned two accused persons namely i) Samir Roy(26 yrs) S/O Phani Roy of Khalaibhaktari, PS- Matigara Dist- Darjeeling and ii) Bijay Goswami (24yrs) S/O Goutam Goswami of Simultala Loknath Colony, PS- Matigara , Dist- Darjeeling. to the effect that today on 27.10.2022 at about 00.15 hrs while performing kalipuja patrolling duty against band fire crackers at Kholaibhaktari area under Matigara PS, SPC found the above noted persons namely Samir Roy and Bijay Goswami were engaged in bursting band firecrackers violating Govt. Order, which creates profound noise at Kholaibhaktari area that causes disturbance of public peace and tranquillity. I repeatedly asked them to stop bursting band firecrackers but they did not pay heed to my words and strongly opposed my lawful direction. Finding no other alternative I arrested them, under proper memo of arrest, informing the ground of their arrest. Accordingly, I seized 17(Seventeen) pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Samir Roy ,06 (Six) Pieces of SAMIM'S Chocolate bomb (band sound Crackers) from the possession of Bijay Goswami and I also seized 05(Five) pieces of used Chocolate bomb (band sound Crackers) found at the Place of Occurrence found at the place at Kholaibhaktari area.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused persons namely i) Samir Roy (26 yrs) S/O Phani Roy of Khalaibhaktari, PS- Matigara Dist- Darjeeling and ii) Bijay Goswami (24yrs) S/O Goutam Goswami of Simultala Loknath Colony, PS- Matigara , Dist- Darjeeling under proper section of law and arrange for its investigation.


