Sir,

In producing herewith two seized vehicles (Shaktiman) truck bearing registration no (1) Registration No - WB 78 / 1281 partially loaded with river bed materials along with 02 (Two) nos. of shovel (Belcha) Iron Made, wooden butt & (2) Registration No WB 71/2691 partially loaded with river bed materials along with 02 (Two) nos. of shovel (Belcha) Iron Made, wooden butt. I SI Maheswar Ch Paul of NBMC OP Under Matigara PS beg to lodge a written complaint against the driver & owner of the above mentioned vehicles to the effect that today i.e 28.10.2022 in course of morning mobile van duty vide GDE No 719 dated 28.10.2022 I along with C/ 967 Jhantu Das & CV - 158 Partha Sarkar reached at Kawakhali Selinghat of Balason river under Matigara PS and found that some persons were loading river bed materials in two Shaktiman trucks bearing registration no WB 78/ 1281 & WB 71/2691 the trucks have in the middle of the rivers, seeing the police van of those truck's driver and others are fled away from the spot. There is sufficient reason to believe that the above noted vehicles drivers have stolen river bed materials from the river of Balason at Kawakhali Selinghat for selling clandestinely. Accordingly, I seized above noted both trucks partially loaded with river bed materials along with total 04 (Four) nos of shovel (Belcha) under proper seizure list. The search, seizure was made in between 11.15 hrs to 11.45 hrs on 28.10.2022.

Under the fact and circumstances I pray before you a specific case against the driver & owner of above noted both seized vehicles may kindly be started and arrange for its investigation.
