in producing herewith two seized vehicles (Shaktiman) truck bearing registration no (1) Registration No - WB 76 / 7838 partially loaded with river bed materials (Sand) along with 02 (Two) nos. of shovel (Belcha) & (2) Registration No WB 73 C/1623 loaded with river bed materials (Sand) along with 02 (Two) nos. of shovel (Belcha). I ASI Krishnendu Roy of NBMC OP Under Matigara PS beg to lodge a written complaint against the driver & owner of the above mentioned vehicles to the effect that today i.e. 28.10.2022 at 14:25 hrs in course of mobile van duty, vide G.D. No 734 dated 28.10.2022, I along with C/ 340 Pranab Adhikary & C/ B36 Lachu Baria reached at Neemtala Ghat of Balason river under Matigara PS and found that some persons were loading river bed materials in two Shaktiman trucks bearing registration no WB 76 / 7838 & WB 73 C/1623 the trucks have in the middle of the rivers, seeing the police van of this truck's driver and others are fled away from the spot, but we managed to intercept the above noted (Shaktiman) trucks. There is sufficient reason to believe that the above noted vehicles drivers have stolen river bed materials (Sand) from the river of Balason at Neemtala Ghat for selling clandestinely. Accordingly, I seized above noted trucks partially loaded with river bed materials (sand) along with 04 (Four) nos. of shovel (Belcha) under proper seizure list. The search, seizure was made in between 14.40 hrs and 15.05 hrs on 28.10.2022.

Under the fact and circumstances I pray before you a specific case against the driver & owner of above noted seized vehicles may kindly be started and arrange for its investigation.
