Subject: F.I.R

Sir,
With due respect and in producing herewith 02 numbers of Shaktiman truck displaying number plate WB/73/4628 and WB/76/7928 loaded with illegal River bed materials under proper seizure list. I, SI Goutam Mallik of Matigara P.S, SPC do hereby lodge this Complaint against the owner of the above noted two vehicles having registration number WB/73/4628 and WB/76/7928 to the effect that on 28.10.22 at 14.25 hrs I received a secret source information that two numbers of Shaktiman Truck having Registration number WB/73/4628 and WB/76/7928 loaded with illegal River bed materials is standing at Patiram Jote near Matrichhaya. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1453 dated 28.10.22 and informed the fact to Officer In Charge, Matigara PS and as per his kind order and direction myself along with force had been to Patiram Jote near Matrichhaya to work out the information in hand. After arrival at Patiram Jote near Matrichhaya and found the above noted two vedhicles (Shaktiman Truck) loaded with illegal river bed materials was parked on the road near Matrichhaya, Patiram Jote. During local enquiry it is learnt that the owner of the said vehicle mines such river bed materials from Balason river by illegal means with a view to sell the same for his illegal gain. Accordingly, we searched the owner of both the above noted vehicles but in vain. Then, I seized the both the above noted vehicle having registration number WB/73/4628 and WB/76/7928 loaded with illegally mining river bed materials under proper seizure list. The seizure was made on 28.10.22 in between 15.35 hrs to 16.45 hrs.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be started against the owner of vehicle No WB/73/4628 and WB/76/7928 and arrange for its investigation.
