Dear Sir,

It has been brought to our knowledge by our staff Mrs Mona Roy, W/o Arnab Ghosh resident of Indra Pally, Shivmandir, Emp Code SLGR 01032 who was on duty today at Matigara Police Station Siliguri Police Commissionerate billing. At around 2.15 pm -2.20pm today two unknown & unidentified person came to enquire about doctor appointment. One person stayed at reception & other person took Mr Alif Islam Sarkar (Emp Code- SLGR01120) who was also present in OPD reception to another corner of the hospital for some enquiry. The person who stayed in OPD reception enquired about doctor appointment, after that he asked for change Rs 500/- to staff Mona Roy. Mona Roy replied that "She doesn't have a change of Rs 500/- instead she can give a change of Rs 1000/-". The person agreed to it & handed over the notes to her. Mona Roy gave her change. After a while the person had asked her to change one Rs 200/- note as it was old. While changing the money Mona Roy took out the bundle of note from drawer. During this moment the person snatched the note bundle from Mona Roy. Mona Roy objected to it & took back the bundle from him. After that the person left the hospital with the other person. After few minutes OPD staff Mona Roy started counting cash & found a shortage of Rs 22500/- in cash box. Mona Roy alerted IT (Mr Subhankar Chakraborty- Emp Code- SLGR01008) for CCTV footage at around 2.30pm & Operations Manager- Mr Jagdeep Kumar & security staffs of the hospital at around 4.16pm.
