Bumasta para Jalpaiguri - 735101, would like to
inform you that on 15.10.2022 at about 5:30 pm
while I was travelling with my two other
colleagues towards our home in Jalpaiguri, met
an accident with a Gas Tanker no. NL-01 A/9958
which was heading towards Siliguri. It was a head on
collision. As a result my vehicle bearing regt. no.
WB 74AK 6576 was badly damaged and the three
passengers were also received severe injuries.

Mr. Tapas Das was admitted in Desun Nurshing
home, Jalpaiguri got operated for his compound
fractures. Mr. Tridib Bum was also got operated
in Apollo Hospital, Kolkata and myself Pintu Kr.
Ghosh was also admitted in Nestia Retreat Nurshing
home with fractured hand (Right) and head injury.
