Sir,

In producing herewith one accused person namely Parimal Saha (58) S/O Lt. Khagendranath Saha of Samar Nagar, Ward No 46, PS Pradhan Nagar, Dist Darjeeling under arrest and following seized articles under seizure -:

1. 05 (five) Packets of Dulal Chocolate Bomb (each packet containing 10 pieces total 50 pieces).
2. 02 (two) Packet black Cat Chocolate Bomb (each packet containing 10 pieces total 20 pieces).
3. 03 (three) Packet King Cobra Electric Crackers.

I, PSI Bandhan Roy of Pradhan Nagar PS do hereby lodged a written complaint against the above mentioned accused person namey Parimal Saha (58) to the effect that today on 30.10.2022 evening myself along force, all of Pradhan Nagar PS were perfuming mobile van duty and this refers to Pradhan Nagar PS GDE No- 1669 dated 30.10.2022. During mobile van at Saman Nagar near Ganesh Ghat, PS. Pradhan Nagar, Dist. Darjeeling found that the above mentioned person was selling the above articles in his shop by violating the Govt. rules and norms and violating the provision of law which may endanger human life and likely to cause injury of human life. Accordingly I seized the same in between 15.20 hrs to 15.55 hrs and also prepared seizure list duly signed by the accused persons and witnesses. Accordingly I arrested them for obstructing the Govt. rules which have been promulgated by the order of Hon'ble High Court, Kolkota vide order No.11.10.2022 in c/w WPA(P) No. 292/2022.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person Parimal Saha (58) S/O Lt. Khagendranath Saha of Samar Nagar, Ward No 46, PS Pradhan Nagar, Dist Darjeeling under proper section of law and arrange for its investigation.
