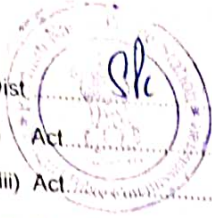

With due regard and humble submission I Sri Kundan Kumar Sah S/O Sita Ram Sah , resident of Railway Colony, Near GRP Thana, Ward No-1, SMC , P.O & P.S- Pradhan Nagar, Siliguri, Dist- Darjeeling do hereby submit the following for your kind information as follows :-

1. That earlier on 25/10/2022 the above named person and his associates created Violence & physically assaulted me, my parents & Sister and other nearby neighbours' and threatened to kill and abused in very dirty Language and even pulled out their wearing clothes and in this a Complaint was lodged by one Kabita Kahar on 25/10/2022 but no steps was taken by your Pradhan Nagar Police instead of the written complaint against them reason not known.
2. That yesterday about 11 P.M when I along with other persons were sitting in the Hanuman Mandir which is just near to my house, suddenly I saw Chandan Das and his associates name not known started to bang the main gate of my house and seeing no one coming out of the house, then he saw me sitting in the Mandir, then he came towards me and took out knife from his pocket and his friends caught my hands and Chandan started to stab upon me with knife and he stab on my stomach and hit me on my head with a Iron Rod and threaten that he would kill me as my parents and other have made complaint against him and his friends at Police Station on 25/10/22.
3. That the entire matter was witness by several people nearby and when I cried for help then Chandan Das and his associates fled away and threaten that he will again come and Murder me and my family members and would also Rape my sisters and will make the life miserable.
4. That the local people and my parents took me to the Siliguri District Hospital in a very bad condition in order to save my life. And the Pradhan Nagar Police Came but did not take any action against them.
5. That if the Police have had taken any legal action against the above named person and his associates on 25/10/2022 against the Written Complaint of Kabita Kahar then this kind of incident would have been avoided.
6. That as no action was taken against the above named person and his associates hence their Courage of Criminal act & activities increased rapidly and they are thinking themselves as Don that area as no one can do anything to them.


