Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Sri Rakesh Sarkar, S/O Nanigopal Sarkar, resident of Sitala Mandir Road, Sevoke Road, Siliguri, Ward No-44, SMC, Dist- Jalpaiguri, West Bengal 734001, P.S Bhaktinagar (ph no- 7478296470) and Sri Bapi Das (Ph-7908914378), S/O not known, resident of Bidya Chakra Colony, Ward no 44, P.O Sevoke Road, P.S Bhaktinagar, Dist Jalpaiguri.

While on a routine inspection of Chat Puja Ghats, in one of the Ghats having address Sri Sri Chhat Puja Bidya Chakra Ghat Committee, Bidya Chakra Colony, Ward No - 44, Siliguri Municipal Corporation, Dist Jalpaiguri, P.S Bhaktinagar, West Bengal, I, Suman Sengupta, Divisional Engineer & Station Manager, Power House CCC, WBSEDCL along with Sri Jyotiska Sengupta, Sr Office Executive, Power House CCC, WBSEDCL and other technical staffs observed that Sri Rakesh Sarkar, member of the above mentioned Ghat committee was enjoying power in an authorized manner.

We entered the premises at 2130 hrs on 30.10.2022. Then it was observed that the power was being used in an unauthorized manner via directly hooking by a service cable from the L.T Network of WBSEDCL. Total unauthorized physical load observed on site was 1. Flood Lights of 3 nos of 1000 watts each, i.e 3000 watts. Therefore a total Load of 3000 watts or 3 Kw was observed. Therefore committing a crime for theft of power as per section 135 (1) (a) of the Electricity act 2003 amended on 2007 of India. All the electrical appliances were installed by Sri Bapi Das, and was well informed about the unauthorized use of power, therefore committing a crime under Section 150 of the Electricity act 2003 amended on 2007 of India. The connection was not disconnected as doing so might hurt the sentiment of the devotees present in the Chat Puja Ghat at the moment. A copy of the inspection report was handed over to Sri Bikash Roy, as informed to be a member of the Ghat Committee, as Sri Rakesh Sarkar refused to receive it. We exited the premises on 2200 hrs.

Thus you are requested to kindly initiate an investigation against Sri Rakesh Sarkar under Section 135 (1) (a) of the Electricity act 2003 amended on 2007 of India and Sri Bapi Das under Section 150 of the Electricity act 2003 amended on 2007 of India.
