Sir/Madam,


This is hereby to inform you that I received an SMS mentioning the disconnection of my electricity connection from +91 8827122073 at 12.28 PM. In the message, it was mentioned to call the electricity officer at 9330787885. As per the instruction received, I called the said number and after instructions were received from the male voice on the opposite side, I installed a quick support app and shared the generated ID with that person. Following the installation, a total amount of Rs. 2,40,890 was deducted in five transactions from my bank account (S/B account:30065923634 Branch Siliguri court). Upon realizing the fraud I have already blocked my ATM card and changed the login credentials of my net banking account. The details have been communicated at my branch.

I hereby request you that kindly register my complaint in this regard and help me to recover the lost amount from my account.
