I, **BIRENDRA SHARMA**, S/O Radhe Sharma, Resident of Durga Guri, New Darjeeling More, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, do hereby want to inform you as follows :-


1. That I am the law abiding citizen of India.
2. That I am the secretary of "UJANU YUBA SANGA", situated at Durga Guri, New Darjeeling More, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling.
3. That since last few months one person namely, **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav, resident of Ward No. 45, Durga Guri, New Darjeeling More, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling started to create disturbance in our locality in drunken condition by creating threat to the women of our locality and the aged persons as the said **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav used to demand money from the various persons of the locality and if any persons denied to give him money then the said **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav used to beat him mercilessly and used to show his nude physical posture by wear off his clothing and became nude, so that no one can protest against him.
4. That when I asked the said person namely, **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav, to stop his illegal activities then the said person openly threat me that he will do whatever he likes and if I tried to stop him then he will kill my family and implicate me in false case.

That today at about 8.45 p.m. when the said person abusing one of the person of our locality namely Shanbhu Dixit at his house for demanding money illegally from him and when I protested the same the said **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav started to threat me that he will kill me and chased to me tried to hit me an iron rod and somehow I managed to escape from him but the said **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav who is a criminal and drug peddler used to create very much disturbance in the said locality.

6. That the said **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav used to take drug every day and used to spread drug culture to the young boys to our locality.
7. That if any Person tried to protest against him the said **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav used to threaten him to kill and demanded money from him.
8. That the above person namely, **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav, is an antisocial person and consuming alcohol used to extort money from the various business person of the locality as well as engaged with various illegal activities in our locality.
9. That at present from the acts and conducts of the above named one person namely, **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav, resident of Ward No. 45, Durga Guri , New Darjeeling More, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling P.O. & P.S. Pradhan Nagar, Dist. Darjeeling I and my family members passing our days in a frightened condition, anticipating that the said one person namely, **RANJIT YADAV (KHICCHA)**, S/O. Late Hiralal Yadav, resident of Ward No. 45, Durga Guri New Darjeeling More, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling at any time may kill me.


