FIR: ILLEGAL CONSTRUCTION NEAR DEFENCE LAND IN AREA MOUZA KHAPRUL

1. It is intimated that despite concerted efforts by unit personnel and repeated warnings, illegal construction activities are still going on in area Mouza Khaprul. One more incident of illegal construction behind Officers Mess of this unit has come to notice wherein an individual named Mr Runite Oran, S/o Mr Ram Lal is carrying out construction at Pholbari, Mouza, Khaprul of defence land without obtaining No Objection Certificate from Stn HQ Sukna, which is illegal.

It is also intimated that when the unit personnel approach the representative of above mentioned individual, Mr Runite Oran present at the construction site to halt the construction immediately, Mr Runite Oran entered into an altercation and also physically assaulted the troops patrolling the area.
3. In view of the above, you are requested to lodge an FIR against the above mentioned individuals for this act of violation and also send your police party for removal of the illegal construction.
