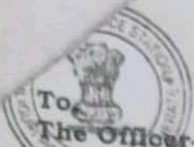

With due respect, I am producing herewith 05 (five) arrested accused persons namely: (i) Ranjit Yadav (27 Yrs) S/O Kanaiyalal Yadav of Mahamaya Colony, Road No-09, PS-Matigara, Dist.- Darjeeling (ii) Ujjal Sutradhar (32 yrs) S/O Narayan Sutradhar of Mahamaya Colony, Road No-09, PS- Matigara, Dist.- Darjeeling (iii) Satyajit Sha (25 yrs) S/O Raj Kumar Sha of Pati Colony, PS- Matigara, Dist.- Darjeeling (iv) Rohan Chhetri (22 yrs) S/O Late Milan Chhetri of Bhutia Busty, Chowrasta, PS- Sadar, Dist.- Darjeeling A/P residing at the house of Priya Chhetri W/O Milan Chhetri of near Circuit House, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and (v) Rajesh Roy (29 yrs) S/O Jogendar Roy of Nicha Busty, Gas Godwn, PS- Matigara, Dist.- Darjeeling and the following articles under seizure :-
1. One iron made sharp cutting weapon called as Bhojali recovered from the possession of accused Ranjit Yadav (27 Yrs) S/O Kanaiyalal Yadav of Mahamaya Colony, Road No-09, PS-Matigara, Dist.- Darjeeling.
  2. One iron made sharp cutting knife recovered from the possession of accused Ujjal Sutradhar (32 yrs) S/O Narayan Sutradhar of Mahamaya Colony, Road No-09, PS- Matigara, Dist.- Darjeeling.
  3. One iron made sharp cutting knife and one torch light recovered from the possession of accused Satyajit Sha (25 yrs) S/O Raj Kumar Sha of Pati Colony, PS- Matigara, Dist.- Darjeeling.
  4. One iron made sharp cutting weapon called as Vojali and one torch light recovered from the possession of accused Rohan Chhetri (22 yrs) S/O Late Milan Chhetri of Bhutia Busty, Chowrasta, PS- Sadar, Dist.- Darjeeling A/P residing at the house of Priya Chhetri W/O Milan Chhetri of near Circuit House, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling.
  5. One iron made sharp cutting weapon called as Hasua recovered from the possession of accused Rajesh Roy (29 yrs) S/O Jogendar Roy of Nicha Busty, Gas Godwn, PS- Matigara, Dist.- Darjeeling.

I, PSI Shekhar Adhikary of Matigara PS, Siliguri Police Commissionerate beg to state that on 02.11.22 at 01.15 hrs received a reliable secret source information that that a gang of miscreants come at near Chandmony play ground under PS- Matigara, Dist.- Darjeeling with deadly weapons and assembled there and making preparation for committing dacoity at Gas Godwn area. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 59 dated 02.11.22 and informed the fact the Officer-In-Charge, Matigara PS, SPC and as per his kind order and direction I along with ASI Tapan Das C/ 974 Mintu Sen, C/1053 Paresch Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, CV-155 Sukumar Das and CV- 387 Sukumar Barman all of Matigara PS ,SPC left for Chandmoni Play Ground under PS- Matigara, Dist.- Darjeeling to verify the veracity of said source input. I also informed the fact to Night RT Van officer PSI Arun Roy and ASI Laxman Saha both of Matigara PS and directed them come to near Chandmoni Play Ground to accompany with us. At 01.45 hrs we arrived at near Chandmoni play ground under PS- Matigara, Dist.- Darjeeling. After a few time RT Van Officer PSI Arun Roy and ASI Laxman Saha along with force came to near Chandmoni ground and accompany with us. At about 02.10 hrs as indicated by the source we noticed that 10/12 persons assembled in a dark place at near a Tin Shed at Chandmoni ground under PS- Matigara, Dist.-Darjeeling and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 05 (five) of them with deadly weapons in their possession but 05/06 persons managed to fled away taking the advantage of darkness. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity in a house at Patio Colony area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made on 02.10.22 in between 02.45 hrs and 03.55 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 06 (six) arrested accused persons namely (i) Ranjit Yadav (27 Yrs ) S/O Kanaiyalal Yadav of Mahamaya Colony, Road No-09, PS- Matigara, Dist.- Darjeeling (ii) Ujjal Sutradhar (32 yrs) S/O Narayan Sutradhar of Mahamaya Colony, Road No-09, PS- Matigara, Dist.- Darjeeling (iii) Satyajit Sha (25 yrs) S/O Raj Kumar Sha of Pati Colony, PS- Matigara, Dist.- Darjeeling (iv) Rohan Chhetri (22 yrs) S/O Late Milan Chhetri of Bhutia Busty, Chowrasta, PS- Sadar, Dist.- Darjeeling A/P residing at the house of Priya Chhetri W/O Milan Chhetri of near Circuit House, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and (v) Rajesh Roy (29 yrs) S/O Jogendar Roy of Nicha Busty, Gas Godwn, PS- Matigara, Dist.- Darjeeling and arrange for its investigation.
