Sir,

In producing herewith one accused person namely (1) Biplab Sah (26), S/O- Sarjun Prasad Sah of Madhya Shantinagar, Near JBS School PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

- (1) 50 (Fifty) bottles of "PETROL" each bottle containing one(01) litre (Total- 50 Litres)

I ASI Ujjal Mandal of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely (1) Biplab Sah (26), S/O- Sarjun Prasad Sah of Madhya Shantinagar, Near JBS School PS Bhaktinagar Dist. Jalpaiguri to the effect that, today i.e 01.11.2022 I along with C/376 Shymal Choudhury and CV/603 Arun Roy while performing evening mobile van duty at Ashighar OP Jurisdiction, Vide Ashighar OP GDE no.12 Dated 01.11.2022 at that time received a secret source information from my source that one Biplab Sah stored a huge quantity of illegal HSD/ Petrol inside his house at Madhya Shantinagar, Near JBS School in order to its illegal selling for his wrongful gain. I immediately informed O/C Ashighar OP and as per his direction wasting no time I along with my accompanied force left for Madhya Shantinagar, Near JBS School to verify the veracity of information. On reaching at Madhya Shantinagar, Near JBS School area as indicated by my source I held raid at the house of Biplab Sah at Madhya Shantinagar, Near JBS School. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of petrol from inside his house. On demand he failed to produce any valid documents for such illegal possession of such articles he gave different statement in different time. Accordingly I seized the above noted articles as alamath of the case, as suspicious under proper memo of seizer duly signed by the witnesses and the accused and arrested the accused person Biplab Sah U/S 41 Crpc under proper memo of arrest and explain the charge against him. There is every reason to believe that the above Petrol in question is stolen article and the person Biplab Sah was possess the said Petrol without any documents. The Search and seizure and arrest were made in between 19.25 hrs and 19.55 hrs on 01.11.2022.

I therefore pray that specific case may kindly be initiated against the accused namely (1) Biplab Sah (26), S/O- Sarjun Prasad Sah of Madhya Shantinagar, Near JBS School PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
