In producing herewith one accused person namely (1) Saukat Ali (38) S/O Late Sikandar Ali of Ram Nagar BSF Camp PO Bil Bore Kobra PS Lalagola Dist. Murshidabad and (2) Uttam Roy @ Bapi (30) S/O Late Anil Roy of Durga Nagar Near Bot Tala, Iskon Mandir Road W/no. 40 PS Bhaktinagar Dist. Jalpaiguri in custody arrested and the following property weighing total 164 grms said to be Brown Sugar & three numbers of Mobile phones, Cash, small weighing machine & small hand bag under seizure:

(i) 1 (One) plastic pouch which contains said to be Brown Sugar weighing 92 (Ninety two) grams Marked as exhibit - "A"

(ii) 1 (One) small digital weighing machine (Battery System),

(iii) Cash Rs. 46,470/- Denomination as, 500x61=Rs.30500/-, Rs.200x 57=Rs. 11400, Rs. 100x25=Rs. 2500, Rs. 50x34=Rs. 1700/-, Rs.20x18=Rs.360/=-, and Rs.10x1=10.

(iv) 1 (One) Merun Coloured small hand bag,

(v) 1 (One) Keypad Samsang mobile handset having IMEI no. 352561119481344 & 352562119481342 and Sim card no. 8902537936

(SL no. I to V recovered from the possession of accused Saukat Ali S/O Late Sikandar Ali).

(vi) 1 (One) plastic pouch which contains said to be Brown Sugar weighing 72 (Seventy Two) Grams Marked as exhibit - "B"

I, S.I Sudip Dutta O/C Ashighar Out Post PS Bhaktinagar SPC do here by lodge this complaint to the effect that on 01.11.2022 at 23.55 hrs received a secret source information that two persons are standing at, Baneshwar More, Ashighar and they possess huge quantity of Brown Sugar with a view to sale the same in Siliguri area and its adjoining area and they could be caught red handed, if apprehended immediately. Accordingly, I diarised the matter vide ASG OP G.D.E No.27 Dated- 01.11.2022 and informed the matter to I/C Bhaktinagar PS and as per his instruction myself along with SI Biswajit Biswas, ASI Inzamamul Hoque, ASI Prahlad Singha, C/877 Munna Ahmed C/729

Dinesh Ch Roy C/ 970 Bikash Roy left for Baneshwar more area in a Govt vehicle no. WB42/R 8829 along with weighing machine & investigation kit and Video Grapher namely Bikram Roy at 00.05 hrs to verify the veracity of the information vide ASG OP GDE No. 28 Dt.02.11.2022. On way to Baneshwar More I called two independent witnesses namely (i) Rakhi Roy(42) S/O Late Ananta Roy of Baneshwar more PO Sevoke Road PS Bhaktinagar Dist. Jalpaiguri and (ii) Sushil Roy (47) S/O Late Magua Roy of do. and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 00.15 hrs on arrival there as identified by the source we surrounded two persons standing at Baneshwar More. On being asked they disclosed their identity as noted above. I informed them about the information in hand and they will be search. After disclosing our identity, I asked them whether they have any objection to be searched in presence of any Executive Magistrate or Gazetted officer and they agreed to be searched in presence of any Gazetted Officer. I served them a notice in accordance with the provisions of law in this regard. Then I send a notice to Shri Passang Topgay Bhutia, ACP, Traffic East SPC through special messenger with a request to appear at the spot and remain present as gazetted officer. After some times at about 00.35 hrs Shri Passang Topgay Bhutia, ACP, Traffic East SPC arrived at the spot. I narrated the whole fact to him and disclosed the identity of Shri Passang Topgay Bhutia, ACP, Traffic East SPC to the accused persons as gazetted officer. Under supervision of Shri Passang Topgay Bhutia, ACP, Traffic East SPC the above noted accused persons were searched keeping strict regard of their decency and recovered two numbers of Plastic pouch containing said to be Brown Sugar, Cash Rs. 60040/-, three numbers of mobile phones, one small digital weighing machine & one Merun coloured small hand bag, which they were kept conceal inside the pocket of their fulpant. The accused Saukat Ali S/O Late Sikandar Ali confessed in presence of Gazetted Officer and other witnesses that he procured the said Brown Sugar clandestinely from Lalgola Murshidabad and other area for its selling to accused Uttam Roy @ Bapi S/O Late Anil Roy and said Uttam Roy @ Bapi selling the same to the local youths of Siliguri and the adjacent area with a view to earn huge money quickly. They also stated that they supplied Brown Sugar to one Md Tammana S/O Md Insaan of Gowala Patty PS Siliguri Dist. Darjeeling and others several times and the said Tammana is involved of this illegal trading of Brown Sugar with them since long. On being asked they failed to produce any documents or license in support of their such possession. Then as per direction of Shri Passang Topgay Bhutia, ACP, Traffic East SPC I weighted the said packets of said to be Brown Sugar with weighing instrument which was kept with us and found the weight of recovered said to be Brown Sugar packets are (i) 92 Grms &(ii) 72 Grms respectively, total weight 164 Grams. Then I packed, labeled and sealed the two numbers of recovered said to be Brown Sugar packets in presence of witnesses, and seized all the recovered articles under proper seizure list under the supervision of Shri Passang Topgay Bhutia, ACP, Traffic East SPC duly signed by the local witnesses and the accused person. The seizure was made in

between 00.45 hrs to 01.15 hrs. Then I arrested the above noted accused persons after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest. The copy of seizure list and memo of arrests have been supplied to the above noted accused persons under receipt. Thus the accused persons violated the terms and condition of N.D.P.S Act. for possessing Brown Sugar without any authority. The videography has been done of whole process by videographer.

Under the above circumstances, I pray to you that a specific case under NDPS Act may kindly be started against the accused persons namely (1) Saukat Ali (38) S/O Late Sikandar Ali of Ram Nagar BSF Camp PO Bil Bore Kobra PS Lalagola Dist. Murshidabad and (2) Uttam Roy @ Bapi (30) S/O Late Anil Roy of Durga Nagar Near Bot Tala, Iskon Mandir Road W/no. 40 PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
