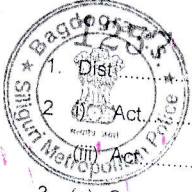

Sir,

I, ASI Jakirul Islam, of Bagdogra PS do hereby producing arrested two accused persons namely (1) Atish Nagasia (21) s/o Samalal Nagasia of Gangaram PS Bagdogra Dist. Darjeeling and (2) Rahul Godwa (23) s/o Gobind Gadwa of Hansqua PS Bagdogra Dist. Darjeeling along with the following seized Fire crackers under proper seizure list viz;

(1) Two Packets containing 18 (eighteen) Nos. Dulal's CHOCOLATE, Electric Sound Firecrackers, Chandan fire Works, SIVAKASI.

I ASI Jakirul Islam of Bagdogra PS, SPC do hereby lodged a written complaint against the above noted accused person to the effect that on 25.10.22 at 22-55 hrs myself alongwith ASI Khagen Barman C/1008 Kanak Roy, CV- 389 Janak Singh, VP-01 Ansalam Kujur, VP-02 Pradip Roy left for performing Spl. night mobile duty in c/w Kalipuja festival as well as prevent to sale and bursting of firecrackers for strict implementation of order of the Hon'ble High Court, Calcutta vide Bagdogra PS GDE No. 1141 dt. 25.10.22. At 23-25 hrs while myself alongwith force arrived near Hansqua More and found that two persons have been bursting of firecrackers at Hansqua More under PS Bagdogra violating the provision of law and also direction, issued by the Hon'ble High Court, Calcutta which may endanger human life and likely to cause injury, accordingly I share the information to the duty officer and also O.C. Bagdogra PS and as per his instruction we apprehended the above noted two persons in presence of witnesses namely (1) Sanjoy Thakur (30) s/o Lt. Chandra Shekhar Thakur of Gangaram Tuna-7 PS- Bagdogra Dist. Darjeeling and (2) Prakash Rotia (26) s/o Lt. Maghu Rotia of Gangaram Tuna-7 PS Bagdogra, Darjeeling and on being searched I recovered above noted firecrackers from their possession as they were violating of the directives of the Hon'ble Court regarding bursting of non-permitted fire crackers which are combustible in nature and endanger to human life and property. Accordingly, I seized the fire crackers under proper seizure list duly signed by the witnesses and also the accused persons and labeled the same in presence of witnesses. As such I arrested the above noted two accused persons and issued memo of arrest on the spot duly sign by them. The seizure & arrest was made on 25/26-10-22 in between 23-35 hrs and 00-10 hrs

Under the above circumstances I pray before you that a specific case may kindly be started against the above accused persons namely (1) Atish Nagasia (21) s/o Samalal Nagasia of Gangaram PS Bagdogra Dist. Darjeeling and (2) Rahul Godwa (23) s/o Gobind Gadwa of Hansqua PS Bagdogra Dist. Darjeeling under proper section of Law, to arrange for its investigation.
