I, **Sri Ajit Kumar Swarnakar** S/O Late Kalidas Swarnakar, permanent resident of Defence Colony, Lane No. 6, P.O. & P.S. Bagdogra, Dist. Darjeeling, W.B., 734013, beg to report you that I am a senior citizen aged 65 years and retired from service and have left eye disability. That since few days both my son **Sri Animesh Swarnakar** and my daughter in law **Smt. Sishmi Guha** who are residing jointly with me have been threatening me with dire consequences.

Sir, their intention is to capture my land and house. That my family pension is the main reason of his fight with me. That time and again he has been demanding my family pension and on my denied he keeps picking up fight with me and my wife. That till date he has been dependent on my pension and does not help me with any monetary assistance. That both my son and daughter in law are businessman and school teacher by profession but they have miserably failed to take care of me and my wife and instead are picking up fight every now and then with an intention to capture my house. That my wife is unwell since long and they keep fighting with her as well.

Sir, yesterday i.e. 27.10.2022 at around 10.40 p.m. my son came back home and when my wife opened the door he pushed her as a result of which she fell on the ground and later had to be admitted to Dr. Bhagat's Clinic and even now she is admitted there. Sir his intention was to kill my wife.

Sir, my daughter alongwith her son has come to my house and staying with me for Kali Puja but my son and daughter in law could not see this and they have been fighting with my daughter on a regular basis. That they have also threatened that they will kill my daughter's son. That they have also threatened my daughter with dire consequences and have hired people from Siliguri who have been constantly calling my daughter over the phone and asking her to leave my house.

Sir, at around 2.15 a.m. my daughter in law called her father who came alongwith few people to my house and threatened my daughter in my absence as I was in Dr. Bhagat's Clinic alongwith my ailing wife.
