Sir,

With due respect, I, ASI Paltu Saha of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against some unknown persons of Kamalpur Chhat Ghat under Bagdogra PS to the effect that on the night of 30/31.10.22 myself alongwith force HG-1118 Dipesh Singha CV- Sontosh Roy were performing night mobile van duty vide Bagdogra PS GDE No. 1361 dt. 30.10.22 and M.C.C. No. 3023/22 dt. 30.10.22 and during mobile duty at 23-25 hrs received information that some of the locals who are newly constructing Bamboo Bridge on the Hulia River near Kamalpur Chhat Ghat illegally without any permission from any concern authority. Accordingly I inform the matter to duty officer and also O.C. PS and as per his direction myself alongwith force proceed to the spot to verify the information and at 23-45 hrs arrived at the spot and found that there already been constructed newly bamboo bridge over the Hulia river at Kamalpur Ghat and on enquiry it could be learnt that the said temporary bridge was making by some local people for the purpose of movement from one side to other side which are violated the order of Hon'ble National Green Tribunal and as per direction of the O.C. PS I informed to all through our mike system attached with Police van regarding the Order passed by Hon''ble NGT and instructed them not to changed any character of the river and construct any temporary bridge over the river which causing disturb to free flow of the river water and also directed to all of that area to remove the new construction bridge immediately, but they not to pay any heed in this matter.

I therefore, pray before you that a specific case may kindly be started against some unknown persons of Kamalpur Chhat Ghat and arrange for investigation.
