Respected Sir,

I, Umesh Sharma, resident of Ganganagar  
Ward No.-05, would like to inform you that my sister,  
Fulman Sharma, had undergone an accident on 23.10.2022  
at around 9 O'clock in the evening, nearby Munna Bhai  
Salon, Opposite Vishal Mega Mart, Buddwan Road. The  
unfortunate incident occurred when a scooter loaded with  
four persons hit my sister while she was coming back  
to her home after work. She got brutally injured and  
beared injury marks on head and other parts of the body.  
Local residents at that point sent my sister to the Siliguri  
District Hospital and was diagnosed there from 23.10.2022  
to 25.10.2022. But due to critical condition of the  
patient, she was referred to North Bengal Medical College  
and Hospital, Siliguri on 25.10.2022 and now her condition  
is more critical. The accused driver was driving through  
the wrong side of the lane and was in a very high speed.  
Delay in Application was due to the medical arrangement  
of the patient.

as soon as possible and do the needful.


