Respected Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complain for theft of Property of WBSedcl beside the premises of Amit Kr Nahata near Swagat Residency, Chayan Para, Siliguri, West Bengal 734008, P.S Bhaktinagar by unknown person. Yesterday evening at around 2030 hrs of 01.11.2022, a report was received for no power, and our LT mobile van was sent to site. Accordingly the report was confirmed by the workers of the Maintenance van that the male female part of the isolator of the 11 KV side of the distribution transformer was missing along with the 11 KV flexible cord. Thus the consumer was left with no power. This incident caused financial Loss Of WBSedcl of around Rs 7500/- (Rupee Seven Thousand Five Hundred Only).

Thus you are requested to kindly initiate an investigation against the miscreants under Section 139 of the Indian Electricity act 2003 amended on 2007.
