Please refer our above 3 numbers of FIRs lodged by Pradhan Nagar, Police Station, Pradhan Nagar, Siliguri against our 3 numbers of complaint letters on the same date.

Now, we would like to bring to your kind notice that today morning at about 05:30AM - 06:00AM one big truck having registration number WB 73 E 5555 entered in our plot number 448 and unloaded 5000-6000 (approx) numbers of bricks after breaking our boundary wall towards Panchayat Road by the side of our nursing home named Greenage Hospitals PVT LTD.

The boundary wall in our Plot No.448 was broken by the following land Mafias/Criminals/Miscreants to start civil work in our Plot No.448, though the above land matter regarding our Plot No.448 at our Dagapur Complex for

which the appeal is pending with the DL&LRO, Darjeeling and the hearing date has not yet been informed to us by the DL&LRO, Darjeeling though the appeal has been filed more than 3 months ago.

In this connection we would like to inform you that we have filed several Title Suits in the court of Junior Division Civil Judge, Siliguri on 05/09/2022 for our Plot No. 445,446,447,448 which has been illegally/ forcibly occupied by those land mafias/criminals/miscreants on the basis of forged documents and the case is pending before the court for verdict.

In the meantime your investigating officers have visited the spot against the above 3 numbers of FIRs and gave instruction not to do any activity on the said Plot No.445,446,447,448 by any body till the decision of the court.

It is to be noted that we have not done any activity on the above plot numbers but the following land mafias/criminals/miscreants today i.e. on 02/11/2022 started their activity by breaking the boundary wall at the side of the Panchayat Road besides our nursing home named "Greenage Hospitals PVT LTD" and unloaded (5000 - 6000) numbers of bricks at our Plot No.448 with the aim to start civil works on the same Plot No.448 which may be protected by your kind help and illegal occupation of land at Plot No.448 till the decision from DL&LRO, Darjeeling and verdict from Junior Division Civil Judge is given by them.

Under the above circumstances you are requested to lodge and FIR against following land Mafias/ Criminals/ Miscreants and take necessary action so that further work may not be started by them till the decision comes from the court as well as from DL& LRO, Darjeeling.

Your kind co-operation and early action in this matter will be highly appreciated.
