With due respect and humble submission, in producing herewith one accused namely Indrajit Das (40) S/O Lt Digendra Das of Natun Para ,Bandh Road, Bhagajotin Colony, Ward No.2 ,P.S-Pradhannagar , Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) 27(Twenty seven) Plastic bottles of Himalayan FATA FATI , 70\* up Country Spirit, each bottle containing 300 ML.

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 02.11.22 in course spl mobile van duty at PS area with force CV /223 Swapan Chhetri ,CV/645 Pankaj Gupta vide PDN PS GDE NO 115 dtd.02.11.22.During Mobile duty at 20.15 hrs ,I received an information that the one person namely Indrajit Das is storing and selling liquor illegally in his house at Natun Para Bandh Road, Bhagajotin Colony, Ward No.2 ,under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search his house recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 20.45 hrs to 21.25 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Indrajit Das (40) S/O Lt Digendra Das of Natun Para ,Bandh Road, Bhagajotin Colony, Ward No.2 ,P.S-Pradhannagar , Dist. Darjeeling and arrange for its investigation.
