Sir,

In producing herewith 3 (Three) arrested accused persons named (1) Bikram Das (21 yrs) S/O Sri Swapan Das of Purba Majhabari (Near Radha Gobinda Market), PO Goghomali, PS Bhaktinagar, Jalpaiguri (2) Sanjay Das (31) S/O Shyamal Das of Jaleswari Bazar, (Near Airtel Office), Eastern Bye pass Road, PO Sahudangihat, PS Bhaktinagar, Jalpaiguri and (3) Raju Mallick (48) S/O Lt Gouranga Ch Mallick of Netajipara Panchanan Road, (Near the house of Ratan Adhikari), PO Goghomali, PS Bhaktinagar Jalpaiguri along with seized articles i.e (i) one knife measuring 12" including wooden handle wrapped from the possession of Bikram Das (ii) one Iron Shabol measuring approx 24" recovered from the possession of Sanjay Das (iii) One iron rod measuring approx 25 inch pointed one end and one torch light recovered from the possession of Raju Mallick under proper seizure list.

I, SI Pradip Kr Singh of Ashighar OP under Bhaktinagar PS/ SPC do here by lodge this written complaint against the above noted arrested persons to the effect that today on 04.11.22 at 00:05 hrs I received secret source information that 10/11 persons have been assembled beside Tharughati River Bank beside Baikunthapur Forest to commit dacoity at the locality. Immediately informed the tip of information to O/C Ashighar OP and as per his kind direction I diarized the fact in GD book vide Ashighar OP GDE No-76 dated 04/11/22 and myself along with ASI Ujjal Mandal, ASI Prolhad Singha, C/376 Shyamal Chowdhury left for Tharughati River Bank beside Baikunthapur Forest to verify the veracity of the information. This refers Ashighar OP GDE No-77 dated 04/11/22 and MCC No-1497/22 dated 04/11/22. At about 00:35 hrs I along with Police party arrived at the spot i.e Tharughati River Bank beside Baikunthapur Forest and after keeping our vehicle at a distant place we proceeded towards Tharughati River Bank beside Baikunthapur Forest on foot and being indicated by the source found from the considerable distance that a gang of 10/11 persons were assembled beside Tharughati River Bank beside Baikunthapur Forest and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase we manage to apprehended 03 (Three) persons and others were fled away from the spot. On interrogation, the apprehended persons disclosed their name & address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that, they along with 7/8 persons were assembled there in preparation to commit dacoity. Accordingly, I managed to call two independent witnesses on the spot and on being search in presence of the independent witnesses from the apprehended persons recovered (i) one knife measuring 12" including wooden handle wrapped from the possession of Bikram Das (21 yrs) S/O Sri Swapan Das which was kept concealed on the back side his waist (ii) one iron Shabol measuring approx 24" recovered from the possession of Sanjay Das (31) S/O Shyamal Das which he was holding on his hand (iii) One iron rod measuring approx 25 inch pointed one end and one torch light recovered from the possession of Raju Mallick S/O Lt Gouranga Ch Mallick. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly signed by them in between 01:05 hrs to 01:30 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.

Under the above fact and circumstances I pray that a specific case may kindly be started against 1) Bikram Das S/O Sri Swapan Das (2) Sanjay Das S/O Shyamal Das and (3) Raju Mallick S/O Lt Gouranga Ch Mallick and others under proper Section of law.
