1. That my marriage was solemnized on 22.01.2017 with Sri Rajesh Ghosh, S/O Lt. Niranjana Ghosh, residing at C/O Sri Nityananda Lal Roy, Bhujipani, P.O. & P.S. Bagdogra, Dist- Darjeeling and corresponding address at Maa Garments, Airport More, P.O. & P.S. Bagdogra, Dist- Darjeeling, according to Hindu Rites & Custom after observing all the formalities of a Hindu marriage through Hindu marriage ceremony on and from my father house situated at Milan Pally (Army Road), Near Shishu Tirtha School, P.O. New Rangia, P.S. Matigara, Dist- Darjeeling.
2. That at the time of my marriage, my parents and other nearest relatives had given so many valuable articles including cash of a sum of Rs. 2,00,000/- only and other household articles for my better future life as per demand of my husband and in-laws members.
3. That after my marriage, I along with my husband, lived and co-habited together as husband and wife in my matrimonial house address mentioned above and out of our lawful wedlock, I gave birth of one male child on 26.02.2018.
4. That Just after few days of our marriage, my husband has started physical and mental torture upon me on the demand of more dowry and when I refused to bring any money from my parents, my husband and in-laws members have started to torture me both physically and
