I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complain for Damarage of Property of WBSEDCL near Hansbela Ashram, Hyderpara Bazar area, Siliguri, Dist Jalpaiguri, P.S Bhaktinagar by vehicle no BR 01 7642, as reported from site. Today morning at around 600 hrs of 04.11.2022, a report was received by the docketing system of WBSEDCL regarding a vehicle damaging our infrastructure. The LT Mobile maintenance van of PHCCC was sent to site and the report was confirmed by the workers of the Maintenance van. As reported from site yesterday night at around 0300hrs the vehicle having vehicle no BR 01 7642 had hit the kiosk of the 160Kva transformer damaging the properties of WBSEDCL. Photographs Of the Incidents were taken and are attached here with. It was found that the L.T Distribution kiosk along with its accessories and other service infrastructure materials was damaged causing a Financial Loss Of WBSEDCL of around Rs 32926/- (Rupee Thirty Two Thousand Nine Hundred Only).

Thus you are requested to kindly initiate an investigation against the owner of the vehicle no BR 01 7642 under Section 139 of the Indian Electricity act 2003 amended on 2007.
