I, the undersigned being the elected Councillor of Ward No. 5 of Siliguri Municipal Corporation would like to draw your serious concern on the very incident as experienced by me to the effect that on 30/10/2022 at around 9:00 AM when I visited the Chhat Puja Ghat situated at Ganga Nagar Road No-2 Ghat area for verifying the arrangement of the very puja, 1) Surendra Ray, 2) Raja Ray, son of Surendra Ray, along with others, all are residents of Ganga Nagar, Rajiv Nagar, Ward No. 5 of SMC, Siliguri, Dist. Darjeeling, arrived at the very place and started to address filthy languages when I asked them to abstain from making such nuisance in said place, they started to misbehave with me and addressed filthy languages raising my caste in public place which is really amounted to be immense hardship for me. Even the said miscreants along with their associates physically harassed me by giving forcible push as well as intentionally molested me under gathered manner. If it is the situation of our city wherein an elected public representative was not save at all and due to under mental distress I could not able to prepare myself to lodge this present complaint and under being stable position, right now I'm filing this present complaint seeking strict action against the above miscreants.

So it would be kind enough to treat the present complaint as FIR and take appropriate action/s against the above miscreants for the proper administration of Justice.
