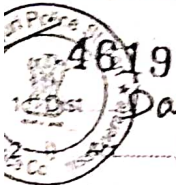

I SURENDRA RAY SON OF LATE MANGAL RAY RESIDENT OF GANGA NAGAR WARD NO 5, SILIGURI P.S-SILIGURI DIST- DARJEELING BEG TO RESPECTFULLY INFORM YOU THAT TODAY ON DATED -02-11-2022 ALMOST 8.30 O' CLOCK AT NIGHT WHEN I WAS CAME BACK MY HOME FROM MY JOB IN THAT TIME MORE THAN 4 PEOPLE STOPPED ME NEAR GANGA NAGAR ROAD AND STATRED ABUSING ME WHEN I ASK REASON FROM THEM IN THAT TIME A PERSON CAME AND SLAPED ME DUE TO THIS MY EYE GLASSES WERE BROKEN CAUSE I WAS HAVING TROUBLE TO SEEING AFTER THAT A PERSON NAMED ASHOK MAHATO ASKED SOMEONE TO KILL ME THAT A PERSON TRIED TO HIT ME ON MY HEAD WITH A WOODEN STICK WHEN I PUSHED HIM SUDDENLY HE HIT ON MY BACK WHEN I FELL ON THE ROAD THEY HIT ME THEIR FEET THEY ALSO HIT MY GENITALS WITH THEIR FEET DUE TO WHICH I HAVE SUFFERD SERIOUS INJURIES,A ANOTHER PERSON TORN MY CLOTHES AND TOOK OUT ABOUT 3200 RUPEES FROM MY POCKET,THEY ALSO BROKEN MY GOLD CHAIN FROM MY NECK,THEY HELD MY THROAT TOO WHEN I PUSHED THEM AND STARTED SHOUTING LOUDLY THAT TIME THEY RAN AWAY, LOCAL PEOPLE OF THEIR LOCALITY TOOK ME AT MEDICAL SHOP FOR TREATMENT.
