Sir,

I, SI Upen Chetri of Siliguri P.S under Siliguri Police Commissionerate do hereby lodged this written complaint against 1) Ratan Roy (21 yrs) S/O- Pulin Roy of Rana Nagar Matigara Dairy Firm, PS- Matigara, Dist- Darjeeling, 2) Ashim Roy (27 yrs) S/o Anil Roy of Rana Nagar Matigara Dairy Firm, PS- Matigara, Dist- Darjeeling, under arrest along with one (01) seized Truck having Regd. No. WB - 76A/8003, loaded with sand.

In this regard I beg to report, I SI Upen Chhetri of Siliguri P.S under Siliguri Police Commissionerate lodged a written complaint to the effect that on 04.11.2022 at about 01.20 hrs in course of Night mobile van duty I received source information that Truck having Regd. No. WB 76A 8003, loaded with sand which the above noted driver had received fraudulently. The driver namely Ratan Roy loaded the sand from Balasan river, Matigara and availing the Hill Cart Road to Venus more side. Accordingly, I along with force had been to Venous More for special checking against illegal mining and also to verify the veracity of information. On reaching at venous more, I found the above mentioned truck partially loaded with river bed materials. On demand the driver could not produce any valid or relevant documents in support of said vehicles and he also failed to produce the valid documents relating to the loaded sands. On further grilling he stated that he procured the sand fraudulently somewhere from Balasan river, Matigara side and taking the same for disposal somewhere at Siliguri for his wrongful gain. Accordingly, I seized the said truck partially loaded with river bed materials in presence witnesses under proper seizure list and also arrested the above noted driver u/s- 41 Cr.P.C under proper Memo of Arrest. The whole process of search and seizure was made in between 01.25 hrs to 02.25 hrs.

Therefore, I pray before you that, a specific case against the driver namely 1) Ratan Roy (21 yrs) S/O- Pulin Roy of Rana Nagar Matigara Dairy Firm, PS- Matigara, Dist- Darjeeling, and his associate 2) Ashim Roy (27 yrs) S/o Anil Roy of Rana Nagar Matigara Dairy Firm, PS- Matigara, Dist- Darjeeling, of the Truck under proper section of law.
