Respected Sir,

I, Soma Biswas, R/O Sreema Sanyal, Babupara, Siliguri, w/o Kumarath Biswas, would like to inform you that Sri Asim Kari, S/O Lt. Nirod Kari, R/O South Babupara, near Babupara Boy's Club, Siliguri has been a close family friend since years. He is a man of influence. Yesterday, 3rd November 2022, ~~my~~ I received a call from him at about 7:00pm., requesting to come to my place to discuss an urgent matter. I allowed him to come as he and his wife, has been a very good friend of mine and my husband. After arriving, he started giving me bad proposals and tried to instigate me against my husband. After arriving, he started giving me forceful threats to accept his bad proposals. I protested and forced him out of my house. While leaving, he threatened me and warned me to cause harm to my family in future. Today suddenly at about 6:45pm., he came to my place again when I was with my daughters, one of them being a minor and other an infant. On opening the door, he forced his way into the house and headed straight to my bedroom, while pulling my elder minor daughter by her hand forcefully and started using filthy languages in front of my daughters. When I tried to protest, he grabbed me by my hair and pushed me into the wall while taking hold of my clothes, with the intention of disrobing me. On trying to free myself, I failed and he finally disrobed my modesty. He threatened me saying, "बापि को बुरा बुरा लडाई करे शकता, नोतरा फिरो को बुरा Rape कराता". He further threatened my husband's life over telephone.

Therefore, I request you to take necessary legal actions immediately against the above named, Asim Kari as we are passing every hour with a fear of death.
