Sir,

This is to inform you that, yesterday i.e. 04.11.2022 at around 03.30 p.m. 06 nos of cutouts have been stolen from the kiosk box of distribution transformer at Pritilata Sarani, Hyderpara, Siliguri near Japan More (D.T.R. Code-9M03Z) by some unknown miscreants causing disruption in nearby power supply. It's not only a deliberate act of theft of electrical property but intentionally removing the cutouts and leaving the power cable terminals open could have lead to fatal accident.

So, this is to request to your good office to register a F.I.R. u/s 136(1)(a) and u/s 140 Of Electricity Act 2003 so that the matter can be thoroughly investigated for taking necessary actions at the earliest.
