Sir,

In producing herewith one accused person namely 1.Sankar Chhetri (M-48 Years) S/O-Lt. Mandaksh Chhetri of Yoksom, Ghezang, PS-Yoksom, West Sikkim, State-Sikkim along with following articles under proper seizure list-

- 1] 48(Fourty-Eight) Bottles of Royal Blue Whiskey each bottle containing 180 ML.
- 2] One Mahindra Savari Vehicle having registration No. SK 02J 0527.

I, PSI Chiranjit Saha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1. Sankar Chhetri (M-48 Years) to the effect that on 05/06.11.2022 during my special night mobile van duty received a source information that one person with Mahindra Savari Vehicle having registration No. SK 02J 0527 is carrying huge quantity of Liquor in the said vehicle which was coming from Sikkim via Salugara under Bhaktinagar PS towards Siliguri without any valid license to sell the same in Siliguri area for his wrongful gain. Accordingly I informed the matter to the I/C of the PS, and as per his kind direction myself along with ASI Dipak Karmakar, C/986 Rajib Sarkar, CVF/-614 Sumit Roy, CVF /-935 Biplab Roy, had been to Salugara under Bhaktinagar PS to verify the veracity of the information. At about 23.05 Hrs we reached at Salugara Bazar. In the meanwhile I called two Independent witnesses namely 1.Rajib Rava(M-19 Years) S/O-Bablu Rava of Vivekananda Nagar, PS-Bhaktinagar, Dist- Jalpaiguri 2.Ankit Chhetri (M-23Years) S/O- Lt.Kumar Singh Chhetri of Farabari, Nepali Busty, PS-NJP, Dist- Jalpaiguri and disclosed our identity and informed about the information and requested them to accompany us in the whole process during search and seizure. Then we started Naka Checking there. As per identification by source I managed to stop the said vehicle and found one male person was sitting in driving seat of the vehicle. Subsequently, I along with Officer and force searched the vehicle and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the Driver of the Vehicle and was carrying liquor towards Siliguri for the purpose of selling. Further being searched the above noted seized articles were found in his vehicle. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in carrying and selling such Liquor to Siliguri without any valid license for last 03(three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list as well as seized the Mahindra Savari Vehicle having registration No. SK 02J 0527 in which he was carrying said liquor, in presence of independent witnesses and arrested the above mentioned person namely 1. Sankar Chhetri (M-48 Years) S/O-Lt. Mandaksh Chhetri of Yoksom, Ghezang, PS-Yoksom, West Sikkim, State-Sikkim after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 23.15 hrs to 23.45 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.




