I Debasish Roy, S/O Sri Indira Mohan Roy, resident of Salugra Bazar, Police Station - Bhakti Nagar, District Jalpaiguri do hereby lodge this written complaint to the effect that I got marriage with Sant Sunita Chhetri, d/o Nirpa Chhetri of Salugra East, Bhakti Nagar, District Jalpaiguri on 2/6/2021 and we have two minor daughters out of said marriage.

Since last one year I noticed that one person namely Siddhartha Mangar, S/O Late Krishna Mangar of Mangpu was disturbing my wife by several means with illegal intention. He used to send adult messages and made unpatriamentary comments to my wife. I protested several times but did not lodged any complaints because my wife requested me not to do so but surprisingly I noticed that somehow that Siddhartha Mangar build up a relation with my wife for illegal means and he used to blackmail her by several means. My wife took money from my home without informing me to fulfil his illegal demands. I latter on came to know these facts from my wife.

On midnight of 5/11/2022 at about 2:30 P.M I noticed that my wife found missing from my home and she took away money and Jewellery with her. I received information and got knowledge that said Siddhartha Mangar with illegal motive had abducted my wife by illegal intention and forcefully took my wife with him. My wife was being blackmailed by this Siddhartha Mangar since few months and he
