I am producing herewith Four (04) arrested accused person namely (1) Santanu Sarkar(34) S/O Nepal Sarkar of Millanmore,Ps.Pradhan Nagar, Dist-Darjeeling, (2) Jiten Munda(35) S/O Lt. Walter Munda of Mialan More,Shishudangi,Ps.Pradhan Nagar,Djg, (3)Arjun Bahadur Dorjee(25) S/O Nag Bhadur Dorjee of -DO-, (4) Pradip Sarkar(32) S/O Anil Sarkar of Kranti Majhgaon,Malbazar ,Dist-Jalpaiguri along with following seized articles, Viz :

- (1) One torned Condom
- (2) One Mobile Phone OPPO ,IMEI NO. 266768065384179 and 266768065384161 of Jiten Munda.
- (3) One Mobile Phone OPPO AI Camera of Santanu Sarkar.

and also producing herewith 03 (THREE) recovered victim ladies namely 1) Dipali Sarkar(38)W/O Gokul Sarkar of Kranti,Malbazar, 2) Shibani Baroi(33)W/O Lt. Bhajan Baroi of Ambari Falakata,Ps. Njp, Jpg, 3) Nandita Sunam (33) D/O Deb Kumar Sunam of Rajbari Para,Ps.Kotwali,Coochbehar.

I, SI. Haren Kumar Mohanta of Siliguri PS/SPC do hereby lodge this complaint against the following accused persons (1) Santanu Sarkar(34) S/O Nepal Sarkar of Millanmore,Ps.Pradhan Nagar,Dist-Darjeeling, (2) Jiten Munda(35) S/O Lt. Walter Munda of Mialan More,Shishudangi, Ps.Pradhan Nagar, Djg,(3)Arjun Bahadur Dorjee(25) S/O Nag Bhadur Dorjee of -DO-, (4) Pradip Sarkar(32) S/O Anil Sarkar of Kranti Majhgaon,Malbazar ,Dist-Jalpaiguri to the effect that today on 05.11.2022 at 23:50hrs hrs I received a specific information that a prostitution racket is going on where girls from outside places of Siliguri took part and customers are being arranged over phone call in the H/O Smt Swapna Roy W/O Late Dr. Dipak Roy situated at Khela Ghar More, Hakimpara under Siliguri PS for their wrongful gain using the house as brothel and money transactions was made in this purpose also received information that the said house owner and his associates runs the business of prostitution since long.


The matter was diarized vide Siliguri Ps GDE no266 dtd. 05.11.22. Accordingly , as per direction of I/C PS. myself along with SI. Basudev Guha, SI. Sumit ^{Ray} ~~Re~~ wat ,ASI. Shiben Sarkar, PSI. Biswajit Sarkar, ASI. Surajit Mullik of Panitanki TOP, Const/1195 Tapan Halder, CV/878 Dipak Singha , LC/1282 Swastika Sharma, LHG/Bharati Biswas had been to verify the information situated at Khela Ghar More, Hakimpara W/No. 17, PS- Siliguri , Dist- Darjeeling . There is strong reason to believe that a search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of offender. On way to Khela Ghar More I asked for the presence of I.C Siliguri PS at the spot as a gazetted officer which he agreed .

On 06.11.22 at about 00:15 hrs we reached at Khelaghar More, Hakimpara under Ps Siliguri. As I/C Siliguri, Ps reached at the spot, we then held raid and entered the H/O Swapna Roy where four male and three female persons found in compromising condition. On interrogation they disclosed their name and address as (1) Santanu Sarkar(34) S/O Nepal Sarkar of Millanmore,Ps.Pradhan Nagar, Dist-Darjeeling, (2) Jiten Munda(35) S/O Lt. Walter Munda of Mialan More,Shishudangi,Ps.Pradhan Nagar,Djg, (3)Arjun Bahadur Dorjee(25) S/O Nag Bhadur Dorjee of -DO-, (4) Pradip Sarkar(32) S/O Anil Sarkar of Kranti Majhgaon,Malbazar ,Dist-Jalpaiguri and three (03) female namely 1) Dipali Sarkar(38)W/O Gokul Sarkar of Kranti,Malbazar, 2) Shibani Baroi(33)W/O Lt. Bhajan Baroi of Ambari Falakata,Ps. Njp, Jpg, 3) Nandita Sunam (33) D/O Deb Kumar Sunam of Rajbari Para,Ps.Kotwali,Coochbehar, but they gave contradictory statement about their relationship and their presence in the room in compromising condition. On being search the rooms of the house owned by Smt Swapna Roy found One torn Condom which was lying on the floor. On being asked the female persons they stated that they are being called by the house owner who runs a illegal prostitution business and the said house owner arranged customers and allows them to use the flat as brothel by involving them in sexual act and also take money from them.

On interrogation the male persons also disclosed that the flat owner and his associates on 05.11.22 arranged customer they further admitted that one Mona Bose is the main pimp who offered them girls and allowed them using the house as brothel and they invites prostitutes from different areas and allow them to run prostitution using their flat as brothel for their wrongful gain and the detained person . Accordingly, I seized all the above said articles duly signed by the witnesses. I then arrested above said four(4) persons U/S 41 Cr.P.C issuing memo of arrest duly signed and acknowledged by each, it is to be mentioned here that victim ladies were separately searched by female constables considering strict decency to their persons and found nothing to be seizure . The seizure was made between 00:50hrs to 01:15 hrs While leaving from the spot the accused person also disclosed that they came in a motor cycle bearing Regd, No WB74BE 2653(Splender)which was also brought seized under proper seizure lists.

Under the above circumstances , it is prayed that a specific case may kindly be started against the below mentioned persons (1) Santanu Sarkar(34) S/O Nepal Sarkar of Millanmore,Ps.Pradhan Nagar,Dist-Darjeeling, (2) Jiten Munda(35) S/O Lt. Walter Munda of Mialan More,Shishudangi,Ps.Pradhan Nagar,Djg,(3)Arjun Bahadur Dorjee(25) S/O Nag Bhadur Dorjee of -DO-, (4) Pradip Sarkar(32) S/O Anil Sarkar of Kranti Majhgaon,Malbazar ,Dist-Jalpaiguri and the absconded house owner named Smt Swapna Roy W/O Late Dr. Dipak Roy situated at Khela Ghar More, Hakimpara under Siliguri PS and her associates namely Mona Bose, and also request for safe custody of the Ladies namely 1) Dipali Sarkar(38)W/O Gokul Sarkar of Kranti,Malbazar, 2) Shibani Baroi(33)W/O Lt. Bhajan Baroi of Ambari Falakata,Ps. Njp, Jpg, 3) Nandita Sunam (33) D/O Deb Kumar Sunam of Rajbari Para,Ps.Kotwali, Coochbehar and arrange for it's investigation.
