Respected Sir,

I, Md. Akbar Ali, Son of Late Md. Basir @ Basiruddin, resident of Khoplashi, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, would like to lodge this complaint against (i) Debi Pyne, Daughter of Late Nitai Chandra Pyne, resident of Champasari, near Kall Mandir, Ward No.- XLVI of S.M.C., P.O. & P.S.- Pradhan Nagar, Dist.- Darjeeling, (ii) Md. Samiuddin, (iii) Md. Aminuddin, (iv) Mubarak Hussain, (v) Md. Gunik and (vi) Md. Ainul, all are sons of Md. Isaruddin, all are residents of Khoplashi, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling.

Sir, my grand-father viz. Md. Jafruddin was the recorded owner-in-possession of the land measuring 5.35 Acre, recorded in L.R. Khatian Nos.- 7, 9, 46, 86 and 118, appertaining to and forming part of L.R. Plot Nos.- 386, 387, 412 and 414, situated at Mouza- Khoplashi, in J.L. No.- 21, within Police Station- Matigara, Dist.- Darjeeling.

After the demise of Md. Jafruddin, his sons and daughters viz. Md. Isheruddin, Md. Basiruddin, Md. Kamiluddin, Amina Khatun and Jamila Khatun had inheritate the aforesaid land, as Md. Jafruddin had not transferred or sell a single portion of land from his aforesaid land.

Subsequently, I alongwith other legal heirs of deceased Md. Isheruddin, Md. Basiruddin and Md. Kamini @ Kamiluddin @ Kamaluddin had jointly inheritate the respective portion of undivided share of the aforesaid land, as per respective ratio of share of our deceased father deceased uncles.

Sir, suddenly, I have come to learn that the Accused No.- 1 viz. Debi Pyne In collusion and in connivance with the Accused Nos.- 2 to 6 have illegally procured false and fraudulent Khatians in the name of several persons deleting the name of our deceased grand father, deceased father and deceased uncles.

Sir, very recently I have also come to learn that said Debi Pyne has illegally sold and transferred some portion of our aforesaid land, keeping us in dark and absolutely ignoring our existence with an intention to cheat and defraud us from our rightful properties in a deceitful manner.

Sir, said Debi Pyne has a close contact with the office of the B.L. & L.R.O., Matigara and absolutely taking entire officers and office staffs in her hand by giving them a hue bribe, said Debi Pyne has illegally and fraudulently delete our name from the Khatians by producing procured and manufactured false and fraudulent legal heirs certificate, false voter identity cards, Aadhaar Card and other documents.

Sir, in this way, the aforesaid persons have jointly earned a huge sum of Rs. 2 Crore for cheating us and the aforesaid persons have misappropriated the aforesaid amount for their illegal and malafide gain and also with an intention to deprive us from our legally entitled properties and monies.

Sir, neither my father deceased viz. Md. Basir @ Basiruddin, nor myself and or other legal heirs of Md. Basiruddin had/have ever been sold a single portion of land from the respective share of my father or ourselves.

I, therefore, am requesting you to take appropriate drastic legal actions against the aforesaid persons in accordance with law and your good office and urgent co-operation is very much expected in this regard.
