I, Ramjan Ali, Son of Md. Basir @ Basiruddin, resident of Khoplas, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, would like to lodge this complaint against (i) Sri Ram Naresh Pandit, Son of Shyam Bahadur Pandit, resident of Sainik Puri, Khaprail, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, (ii) Smt. Tara Joshi, wife of Sri Emlal Joshi, resident of 9A Cant Forest Lodge, P.O. & P.S.- Shillong, Dist.- East Khasi Hills, in the state of Meghalaya, (iii) Smt. Bishu Thapa, wife of Late Nirpat Kumar Thapa, resident of 16 JMG Road, Nayabazar, P.O. & P.S.- Kurseong, Dist.- Darjeeling and (iv) Gouranga Barman, son of Late Godadhar Barman, resident of Kamlabari, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling.

Sir, the aforesaid persons have taken one General Power of Attorney being No.- 96 for the year 2020 in their names, from myself, Md. Akbar, Faguni Nechha and Zarina Khatun, by completely misguiding us, by saying that they will only look after and manage our properties measuring altogether 53 Decimal, recorded in L.R. Khatian Nos.- 2609, 2610, 2611 and 2612 respectively, appertaining to and forming part of L.R. Plot Nos.- 386, 387, 412 and 414 respectively, situated at Mouza- Khopalasi, in J.L. No.- 21, within Police Station- Matigara, Dist.- Darjeeling.




