Sir,

I, SI Gautam Laskar of New Jalpaiguri Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the accused persons namely i) Prakash Sarkar Mob. No. 7908969868, ii) Ajay Sarkar Mob. No. 7908657511, iii) Sanjib Das Mob. No. 7001875801, iv) Shyamal Sarkar Mob. No. 9832510667 and others all of the member of Yuba Shakti Shangha, Porajhar Chhat Puja Committee, PS NJP, Dist. Jalpaiguri to the effect that today on 30.10.2022 at 12.05 hrs myself along with force namely C/ 318 Arjun Kr. Mahato c/1439 Tapash Roy both of New Jalpaiguri PS, Siliguri Police Commissionerate performing Spl. van duty under New Jalpaiguri PS, Siliguri Police Commissionerate on the occasion of Ld. Chhat Puja. This refer New Jalpaiguri PS GDE No.1337 date: 30.10.2022. While performing Spl. van duty at Porajhar Chhat Puja Ghat we found that Porajhar Chhat Puja Committee makes several measure and thus violated the Govt. order as well as the order of Green Tribunal. They also make a bamboo gate on the way of Porajhar Ghat without obtaining any permission from competent authority without any precautionary and safety measure which was fell down which may cause endanger to human life. Seeing our Police party the accused person fled away from that place.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person namely i) Prakash Sarkar Mob. No. 7908969868, ii) Ajay Sarkar Mob. No. 7908657511, iii) Sanjib Das Mob. No. 7001875801, iv) Shyamal Sarkar Mob. No. 9832510667 and others all of the member of Yuba Shakti Shangha, Porajhar Chhat Puja Committee, PS NJP, Dist. Jalpaiguri under proper section of law and arrange for its investigation.
