Sir,

I, Sri Tapan Mazumder, son of Late Satyendra Kumar Mazumder, resident of Nivedita Road, Siliguri Municipal Corporation Ward No. II, Post Office and Police Station Pradhan Nagar, District Darjeeling is one of the Partner of NORTH BENGAL DENTAL SOLUTIONS with Dr. Atulana Roy, resident of Flat No. B-204, Mayfair Crown, Jyoti Nagar, Post Office & Police Station Bhaktinagar, District Jalpaiguri, Pin: 734008 and the above Partnership was situated at Nivedita Road, Siliguri Municipal Corporation Ward No. II, Post Office and Police Station Pradhan Nagar, District Darjeeling and our above Partnership were started on and from 15.04.2022 till date with the ratio 30% : 70% i.e. I shall get 30% of profit or loss and Dr. Atulana Roy shall get 70% of profit or loss from the above Partnership. The written Agreement was written and executed on 01.06.2022.

Sir, since the inception of the Partnership, the Accounts of the business maintained by Dr. Atulana Roy, though as per the Partnership Agreement a Bank Account will be opened in the name of the Partnership and the said Account shall operate by both the Partners Jointly.

Sir, I requested Dr. Atulana Roy to pay the expenses of Glow sign Board, Flex Sticker, Electric Charges etc. from the above Partnership, but all the time she assured to pay the above expenses but did not pay the same till date.

I requested Dr. Atulana Roy time and again to submit the statement of Accounts to me but she did not disclose the same and avoid producing the Accounts of the Business with various filthy grounds.

On several requests by me, Dr. Atulana Roy produced one Patient Register to me and another Patient Register was opened to maintain the Accounts further.

It appears from the said Patient Registrar which she produced before me that some pages are over writing in the said Register Book. It is also noticed that the in the 2<sup>nd</sup> Patient Register several pages were missing.

On 21.10.2022 I, asked my above partner Dr. Atulana Roy over phone the cause the missing of the pages from the above register and she assured me to come at the Clinic on the next date i.e. on 22.10.2022 at about 6.00 p.m.

On 22.10.2022 at about 2.37 p.m. my above partner Dr. Atulana Roy call me over phone and asked me to give her the equipments at 4.00 p.m. on the said date but as I was not available at that time I told her to come at 6.00 p.m. as she advised but suddenly she said that she took the equipments on 4.00 p.m. only or she come at the Clinic with the Police.

To avoid any litigation, I did not take any steps against Dr. Atulana Roy, but on 22.10.2022 at about 6.00 p. m. Dr. Atulana Roy came at the Clinic with her mother Mrs. Mitua Roy (Sanyal), brother Mr. Nayan Roy, two staffs viz. 1. Dr. Anita Gurung, 2. Miss Pema and some unknown persons and abuse me with filthy languages and the brother and mother of Dr. Atulana Roy above named tried to assault me and my wife who was present at the relevant point of time and forcefully took all the equipments from the Clinic, except the Dental Chair and one Wall mount Dental X-Ray machine (the above two things are still lying at the Clinic).

That at the time of Leaving the Clinic Dr. Atulana Roy said that she will come on 31.10.2022 and took the above Dental Chair and one Wall mount Dental X-Ray machine from the Clinic and also submit the Books of Accounts.

On 28.10.2022 I asked Dr. Atulana Roy through Whatsapp, to submit the torn/ missing pages and on 29.10.2022 and 30.10.2022 I reminded her through whatsapp and requested to produce the above torn/missing pages. On 31.10.2022 she send the photo of the above torn/missing pages through whatsapp to me.

Sir, from the above it appears that Dr. Atulana Roy collected huge money from the patients but with the intention to cheat me she deliberately torn the pages from the Patient Register and also refused to produce any Books of Accounts to me with the intention to grab the entire profit of the business for her most illegal and wrongful gain but when I create pressure to pay the Bills for the Glow sign Board, Flex Sticker, Electric Charges etc. from the above Partnership, she decided to leave the partnership without paying the same and without paying the profits of the business to me.

It is needful to mention here that as per the Agreement, I paid the establishment costs of the furniture and fixtures, Electric Wiring, costs of Water supply etc. and also pay the rent for the Clinic regularly, but Dr. Atulana Roy for her wrongful gain and grab the entire profits of the business and cheated me and also breach the trust of the above Partnership.

Sir, I invested huge amount of the above Partnership Business to run the Clinic smoothly but Dr. Atulana Roy grab all my investment and profit of the business by way of cheating me for her wrongful gain.

In the above circumstances, I therefore, humbly prayed to treat this complaint as F.I.R and take legal action against the above Dr. Atulana Roy and the other miscreants and their associate for the ends of justice.

I inform you all the facts with the hope of justice. Delay of lodging this F.I.R, if any, be pleased to condone.

Hope your kind co-operation and need full immediate action please.
