- 1. Tetanus toxoid (0.5ml) i.m stat.
- Tab Ibuprofen 400mg-1 tab orally BDAC for 5 days.
- Tab Antacid/ Tab Famotidine 40mg-1 tab orally BDAC for 5 days.
- Tab Co-amoxiclav 625mg-1 tab orally TDS for 5 days.
- Apply Mupirocin ointment locally BD for 10 days/ Dressing of the affected every alternate day with Normal saline/Spirit/Mupirocin ointment for 10 days.
- Switch off to be done in OPD after 7-10 days.
- Visit OPD/ Orthopaedic OPD/ Concerned OPD asap/ Emergency SC
