Sir,

In producing herewith 01(one) accused person namely Ranjan Oraon (30 yrs) S/O Lt Bhagban Oraon Of Menghora, PS- NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12 (Twelve) Bottle of Blu 80 Up country spirit containing 600 ML each.

I ASI Dipak Singha of Milanpally out post under NJP PS do here by lodged a written complaint to the effect that today on 03.11.22 at 17.05 hrs acting on a tip-off source information myself along with C/-1083 Manas Chanda C/ 980 Sadhan Barman, VP 12 Dasarath Roy had been to Menghora under Milanpally OP to work out the information that a huge number of country spirit are stocked in the house of one Ranjan Oraon S/O Lt. Bhagban Oraon of Menghora, PS- NJP, Dist- Jalpaiguri without license to sale the same in the open market. This refers to Milanpally out post GDE No 78 date 03.11.22. On arrival at Menghora at 17.45 hrs and I called local witnesses to witness the raid and on being identified by the engaged source we held raid in the house of Ranjan Oraon and could recover the above noted ID liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liqre proper seizure list and arrested the accused person U/S – 41 Cr.P.C and took him into the custody. The seizure was made in between 18.35 hrs to 19.05 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Ranjan Oraon (30 yrs), S/O- Lt Bhagban Oraon Of Menghora Under Milanpally Out Post, PS NJP, Dist- Jalpaiguri.
