Sir,

This is to inform you that, I Sri Mridul Kanti Das, son of Late Nikunja Behari Das, working for gain at Hotel Appolo and Tour Pvt. Ltd, Mallaguri, P.S- Pradhannagar, District- Darjeeling, PIN- 734003 do hereby like to state as follows:

- 1) That I had purchased a piece of land fully marked and demarcated by a boundary, situated at Jatiakhali under NJP Police station in the year 2019 and since then have been enjoying the possession of the said land.
- 2) That on 15<sup>th</sup> November, 2021 had received a letter through registered post at Hotel Apollo, which was sent by one Md. Sirajul Hock, S/o Md. Jahirul Hock, P.O- Fulbari-II, District- Jalpaiguri.
- 3) It is stated that the contents of the letter are self-explanatory, which goes on to give life-threat to me in the event of failure on my part to pay an extortion amount to the tune of Rs 50-60 lakh for purchase of the piece and parcel of land at Jatiakhali and also for construction of boundary wall around my purchased land.

9) I most humbly request and pray before your goodself to take appropriate legal action against the perpetrators of the crime by initiating specific criminal case under specific provisions of law stated in the Indian Penal Code and to protect me and my property.
