Sir,

With due respect, I ASI-Nilam Swarnakar presently attached with NJP PS under your kind control beg to state that today i.e. on 05.11.2022 at 12.45 hrs I received a secret source information that sand mining was going on at near Naukaghat bridge besides Mahananda river. He conveyed the information to his superior as well as Assistant Commissioner of Police and as per their kind direction he along with N 0089 Shyamal Roy and N 0192 Chandan Roy had been to under Naukaghat bridge near at the bank of Mahananda River and found the vehicle bearing No 1) WB-73D 7807 loaded with Sand, 2) WB-73D 6538, 3) WB-73E 9004 loaded with Sand were sand mining within the 100 meters of Mahananda River violating the lease agreement and was dangerous for Mahananda barrage because of which the barrage could get damaged. Accordingly we chased them but somehow the drivers and others fled away from the Spot.. That there is sufficient reason to believe that the Drivers of the said vehicles have stolen those sand from Sahu River without any Legal Royalty/Paper as per rules, for selling Clandestinely. Accordingly, I seized i) One Dumper bearing registration No.-WB-73D 7807 loaded with 150 CFT of Sand. ii) One Dumper bearing registration No.-WB- WB-73D 6538, iii) One Dumper bearing registration No.-WB-73E 9004 loaded with 150 CFT of Sand after issuing proper Seizure list observing all the guideline issued by the Apex Court. The whole process of search & seizure was made in between 13.25 hrs to 14.05 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the driver of the above noted Dumper as well as the owner of the above noted Dumper and arrange for its investigation.
