Respected Sir

With due honour I Harun Al Rashid, S/o- Late Najrul Islam, R/o- Roop Chandragach, P.O. Fulbarihat, P.S. New Jalpaiguri, Dist- Jalpaiguri, beg to state that my younger brother namely Munawar Hussain is the lawful owner in physical possession of the below scheduled landed property since long and is enjoying all rights, title and interest over the land and have planted panisal trees and tej pata (Bay Leaf) on the said plot of land and has also erected boundary on all sides of the said plot of land by bamboos and other materials.

That my brother is a service man and at present he is in the forest department posted at Chalsa as beat Officer.

That I on behalf of him used to cut the bay leaves every year and sell it.

That yesterday on 4th of October in the morning when the labourers were cutting the leaves of the said plant as usual (1) Mintu Mohd.(2) Mithun Ali (3) Mannan Ali all are sons of Late Mohd. Ali, (4) Azharul Islam (5) Aksarul Islam (6) Taherul Islam all are sons of Nurul Islam, (7) Mukta Ali Choudhury (8) Sakhawat Ali both are sons of Late Sorifuddin Ahmed and (9) Liton Islam S/o- Late Hanif Ali Pradhan, all are residents of Joydeb Vita, P.O. Fulbari Hat, P.S. New Jalpaiguri, Dist- Jalpaiguri entered in to the said plot of land and stopped the labourers from cutting the bay leaf (Tej patta) and when me along with my other brother went to the spot they threatened us to murder us if we stop them. We somehow with the help of the other people of the locality could send them out of the land.

That yesterday again when the labourers went to cut the bay leaves they again stopped them saying that they will kill us if we go to the spot.

They were laden with arms and axes and rods and lathis and other deadly weapons. Their only intention is to kill me or any of my brothers.

That today in the morning I came to know from one of my well wisher that last night some persons entered in to the said plot of land and fell down four to five trees from our land and when I went to the spot today I saw that it is true. The above mentioned persons have done it with the intention to steal the tree and to grab the land. That today they are sitting around the land with axe, soade and other deadly weapon to look after if we are going inside the land. They will definitely fell down/ cut all the trees to clear the land and grab it.

It is worth mentioning here that they are noted land grabbers and land mafiyas of the locality and they are hell bent to kill us and grab the said plot of land. They are very dangerous and antisocial and may cause bodily injury to me at any point of time with the intention to kill me or any of my brother.

I will request you to kindly take strong action against the above mentioned persons so that I can feel secure to move around and to save my brothers land from their clutches for the ends of justice.
