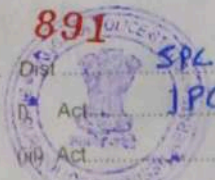



That I Bimla ^{Das} ~~Das~~ the under signed would like to inform you that , Sri Sanjay Das, son of Late Rajendra Das, resident of Sahani Para, Purana Bus stand , P.O & P.S - Matigara, Dist - Darjeeling is my son. That there is wide road Infront of the our house and the said road has been used by other co-resident of that area. That during lock down period one person of that locality namely Rajendra Sahani & his wife Asha Sahani has started their business of stitching in open Road and considering the fact there is an only stitching machine no one objected the same. That after few times Rajendra Sahani and his other family member has started to sell vegetable in the road and same was also unopposed as because no permanent structure/ construction was made from their side. That after few months later, Rajendra Sahani and his wife Asha Sahani along with the support of their son namely Santosh Sahani, Vabisha Sahani & daughter-in-law Reshma Sahani has started a grocery shop and further also started to park their 2 vehicles over the public pathway by grabbing the same, which creates a direct obstruction in our daily normal life.

That after this incident when the local people raised their voice against this illegal act and submit mass petition against the illegal act of the Sahani Family, they all have started to misbehaved with local peoples. That it is pertinent place to mentioned here, Sahani family have already pending criminal cases against them.

That on 26/10/2022 at about 10.30P.M when Sanjay Das standing over the road, all of sudden Rajendra Sahani & Asha Shani have started filthy language against Sanjay Das and threaten him not raise any voice against their illegal activity.

That to this effect on 27/10/22 said Sanjay Das lodged a complaint with the Matigara police Station and Commissioner of Police Siliguri. That under such complaint from the side of Sanjay Das, from Matigara police station one police personal namely Pores Barman visited the spot.

That on 06/11/22 at 11.30 P.M again all the member of Sahani Family have started to threaten our total family with dire consequences and also said the police personnel of Matigara is not able to resist the Sahani family members from their evil desire. That at that point of time my son has gone out from the house to go to police station, in the point of time Santosh Sahani hit my son Sanjay Das with a sharp cutting rod and my son has started bleeding and there upon entire other sahani family member Rajendra Sahani and his wife Asha Sahani along with the support of their son namely Santosh Sahani, Vabisha Sahani & daughter-in-law Reshma Sahani has started to bit my family members. That in that point of time I informed my married daughter namely Nibha Mahato and her husband Tuntun Mahato to protect us from their hand. That after getting such information my son-in-law Tuntun Mahato went to spot with one of his On Prakash Mahato.

That when Tuntun Mahato & Om Prakash Mahato went to the spot, without giving them any time Rajendra Sahani and his wife Asha Sahani, Santosh Sahani, Vabisha Sahani & Reshma Sahani has started to bit them with sharp iron rod and lathi. That due to this incident my son Sanjay Das, Tuntun Mahato, Om Prakash Mahato sustain serious injury and deep cut in their body. That Sanjay and om Prakash sustain deep cut head injury.

That at present all are admitted at North Bengal Medical. That Sahani family is totally ferocious and they have to fear & respect for law. That today my family members are under the danger of life due to the intentional illegal act of all the sahani family member. That due this illegal act Sahani family not only intention hit my family

members with Sharp weapon, but also snatched two gold chain and three gold rings from Tuntun Mahato.

Under the above circumstance, I want to inform you that, Rajendra, Asha, Santosh, Vabisha, Reshma tried to kill my family members and to this effect they intentionally hit Sanjay Das, Tuntun Mahato and Om Prakash Mahato with Sharp cutting weapon to take the revenge of the complainant filed by my son before your authority on 27/10/2022. That all three persons are now admitted in North Bengal Medical Hospital and all of them are unconscious. That I am senior Citizen and this incident took place with my family as because my family stands against the illegal act of Rajendra Sahani and Asha Sahani, Santosh Sahani, Vabisha Sahani & Reshma Sahani.
