I Smt. Asha Sahani, Wife of Rajender Sahan. resident of Matigara, Sahani Para, P.S. Matigara, Dist- Darjeeling, would like to state you the following facts:-

- For 07/11/22 11811-2
1. That I have one open plastic shaded stall at Matigara more in which I sell flowers, chocolate and chips. One Sanjay Das, Son of Raju Das, who is residing in the same locality is very rowdy and dangerous person. Since long said Sanjay Das has been disturbing me and my family members and threatening and blackmailing us to pay him Rs.1,00,000/- to him as tax for carrying on my aforesaid open stall in that area otherwise he would break open my stall and not allow us to carry on my shop in that area.
 2. That Sir, I am very poor person and hardly earn profit of Rs. 100 to 200 per day from my said shop as such I am unable to give any amount to said Sanjay Das.
 3. That as I did not fulfill his such demand, he along with his hired men forming a group started disturbing me and used to abuse me and my husband, whenever they use to see us on the road and even coming at my aforesaid stall and house.
