With due respect and humble submission I, Radhika Singh wife of Uttam Singh resident of Shalkavhita Nimtala, Shivmandir, P.S. Matigara, District Darjeeling would like to pray before you that I am married to above named Uttam Singh in the year 2004 and it is pertinent to mention here that since the very beginning of our marriage my husband never ever liked and respected me and he used to torture me regularly and it has been long 18 years of our marriage but in this long period he never ever treated me as his wife.

It is pertinent to mention here that our marriage and relationship has been 18 years long but every time I wanted a baby my husband never wanted to make babies with me. And it is very unfortunate to mention here that many a times I was pregnant and cried lying in the leg of my husband that I wanted those babies but my husband always used to bring some medicines and use to force me to have those medicines and he many a times also thrashed me in my stomach and drag me in the floor, and used to say if I don't eat those medicines then he would kill that small baby that is being form in my stomach and my pregnancy and forcefully making me eat those medicines happened many a times.

It is also pertinent to mention here that he comes home every day in a drunken condition and locks me in a room and without any reason beats me, pushes me and many a times in a very drunken condition also tried to kill me pressing my neck.

It is also very sad to mention here that my husband is a retired policemen and every time he says that every policemen are his friend and every officers are in his pocket and he can do anything to me and no policemen will listen me as because he has a good hold in police line. It is also pertinent to mention here that my husband is a very cruel and dirty kind of person and also used to sexually

harrash me and he used to brings many prostitute in our house whenever I went outside and now since I stay in different flat and he stays in a different flat in the same building he has become like a pig and brings brings prostitute and he is very much addicted to girls and has a very dirty habit of having sex with many girls.

It is also pertinent to mention here that today at about 8.30 a.m he called me in his flat and when I went in his flat first of all he locked the door and asked me to sit down and when I sat down and asked him what has happened he without any reason started to punch me, beat me dragged me in the floor and was telling that he would kill me and he also tried to kill me with a bottle and pressed my neck and he also kicked me in my belly my neck and here and there and while he was pushing me I some how managed to open the door and ran out I have also sustain injuries in my face, lips and body.

It is pertinent to mention here that now a days its being very difficult for me to live my day to day life with such a threat over me, as he is a very dangerous man and has threatened to kill me when ever he gets chance and thus I be before you to take immediate legal action against him or else he would kill me.
