Sir,

In producing herewith, one Nachima Bibi (F/58) W/O Abul Hossain of Koli Bagan, Dist- Khulna, Bangladesh under arrest and seized article "one Bill for X-Ray of Burdwan Diagnostic & Research Centre Pvt Ltd, NBMC in the name of Nasima Bibi dated 07.11.2022", I ASI Anupam Roy of NBMC OP under Matigara PS, SPC, Siliguri do hereby lodge a written complaint against her to the effect that today on 08.11.2022 at 10.25 hrs received a source information that one unknown Bangladesh National lady aged about 58/60 years entered into India from Bangladesh illegally and now roaming at and around Emergency Ward of North Bengal Medical College & Hospital. Diarised the information vide NBMC OP GDE No. 209 dated 08.11.2022 and as directed by OC NBMC OP, I along with C/728 Biswajit Roy, C/836 Lachu Barla and L/C 271 Basabi Barman left to work out the information vide GDE no. 210 dated 08.11.2022.

At about 10.25 hrs we reached at outside of Emergency Ward and as indicated by the source found one lady in front of the room of Digital X-ray of NBMC. I apprehended her, disclosed our identity and on question she disclosed her name and address as Nachima Bibi (F/58) W/O Abul Hossain of Koli Bagan, Dist- Khulna, Bangladesh. On further interrogation she confessed that she entered into India from Bangladesh illegally about 7/8 days ago for job. On 07.11.2022 she came to NBMC for treatment. On demand she could not produce any document for entering into India. On search one Bill for X-Ray of Burdwan Diagnostic & Research Centre Pvt Ltd, NBMC in the name of Nasima Bibi dated 07.11.2022. Accordingly, I seized the said Bill under proper seizure List and arrested her U/S 41 Cr.PC.

I, therefore, pray before you kind honour that a specific case under proper section of law may kindly be registered against the arrested accused namely Nachima Bibi (F/58) W/O Abul Hossain of Koli Bagan, Dist- Khulna, Bangladesh.
