Sir,

I, Prakash Singh, S/o Late Prahlad Singh, resident of Nivedita Road, Pradhan Nagar, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, do hereby lodge this FIR to the effect that on 31/10/2022 at about 8:30 AM (Morning) while my son Aditya Singh aged about 18+ was going towards Salbari side by a motorcycle bearing No. WB-74BK-0493, suddenly on the way near Delhi Public School, Dagapur a School Bus of DPS School bearing No. WB-73C-5959 dashed him as a result of which my son fell down on the road, and sustained head injury.

The said bus after dashing my son fled away from the spot. Subsequently my son was taken to North Bengal Medical College & Hospital and my son was declared dead.

My whole family was under the state of shock and for said reason I could not lodge the complaint earlier. On our enquiry from the spot we came to know the said Bus No. from a friend of my son who had seen the incident of the accident.

I therefore request you please take immediate suitable legal action against the said driver of Bus No. WB-73C-5959 and thus oblige thereby.
