


With due respect, I ASI Ramesh Bhitrekothey of Bhaktinagar PS, Siliguri Police Commissionerate would like to lodge a written complaint against the accused persons namely Kanhiya Sharma S/O- Lt. Raghunandan Sharma and Pradip Chakraborty S/O- Lt. Patit Paban Chakraborty both of Sarbopally, Ward No-42, PS- Bhaktinagar, Dist- Jalpaiguri along with others.

In this regard, I beg to report that on 05.11.2022 at about 15:35 hrs when I along with force were performing K-37 mobile van duty, I received an information from the local people of Eastern Bypass that some persons are being constructing the temporary tin shed shop on the govt land near Bangla Bazar, under Bhaktinagar PS. Accordingly I inform the mater to I/C Bhaktinagar PS and as per his direction myself along with force left for Bangla Bazar, on arrival at Eastern by pass near Bangla Bazar we found that some persons were constructing temporary tin shed shop on the road side of govt Land near Bengla Bazar, under Bhaktinagar PS, Dist: Jalpaiguri but seeing the police party they managed to fled away from the spot, further enquiry it could be revealed that one Kanhiya Sharma S/O- Lt. Raghunandan Sharma and Pradip Chakraborty S/O- Lt. Patit Paban Chakraborty both of Sarbopally, Ward No-42, PS- Bhaktinagar, Dist- Jalpaiguri and others had been engaged the said labour for construction of tin shed shop on the govt land situated at Eastern By pass road near Bengla Bazar without any valid papers for their illegal gain. But due to interfere of the police party the illegal encroachment of the govt land could be stop. However there is every chance of illegal encroachment at that area by the some antisocial alleged persons in future.

Under the above circumstance, I request you that a specific case may kindly be started under proper sections of law against the above noted Kanhiya Sharma S/O- Lt. Raghunandan Sharma and Pradip Chakraborty S/O- Lt. Patit Paban Chakraborty both of Sarbopally, Ward No-42, PS- Bhaktinagar, Dist- Jalpaiguri along with others and arranged for proper investigation of the case.
